FEEDING DIRECTIONS

Hand feed 2.0 lb to 6.0 lb of this medicated feed per head per day. This will provide from 60 to 180 mg lasalocid per head per day. Intakes of lasalocid in excess of 200 mg/head/day have not been shown to be more effective than 200 mg/head/day. Do not self feed. Allow free access to hay and/or other roughages. Feed grain to animals according to condition desired. Provide clean, fresh water at all times.

WARNING: A withdrawal period has not been established for this product in pre-ruminating cattle. Do not use in calves to be processed for veal.

CAUTION: Consumption of this product by sheep and goats may result in copper toxicity. Do not allow horses or other equines access to formulations containing lasalocid as ingestion may be fatal. The safety of lasalocid in unapproved species has not been established. 00116
